## IMPORTANT INFORMATION, PLEASE READ

- We are honored that the owners allow us to use their property. Please treat the property and its owners with respect. Do not litter. If you smoke, please dispose of your cigarette remains properly, do **NOT** just throw them on the ground.
- There will be volunteers to direct you to the parking area when you arrive. If one is not immediately available to direct you, please ask for parking instructions when you arrive. If you are asked to move your vehicle, please do so immediately.
- Parents are responsible for their children. Interference by your child during the test is grounds for the dismissal of your dogs from the event. If so dismissed, there will be no refund of entry fees. There will be guns at the test site, please keep your children away from them. For your child's safety, please remind them to **ALWAYS** ask permission first, before petting someone's dog.
- Exercising your dog will only be allowed in certain areas away from the test grounds. **ALWAYS** cleanup after your dog and keep him/her on lead.
- It is your responsibility to have your dog under control at all times. If your dog gets loose and interferes with the test, it will be disqualified whether it's run the test or not. There will be no refund of entry fees.
- Failure to follow these guidelines could result in a request to leave the event without refund of entry fees.
- **There will be a handler's meeting at 9:00.** Questions about the test will be answered and a test dog will run.

# WORKING CERTIFICATE

Huron River Labrador Retriever Club will host a Labrador Retriever Club, Inc. WC/WCX test on **Saturday August 12<sup>th</sup>, 2017. THIS TEST IS FOR LABRADOR RETRIEVERS ONLY.**

**Dead ducks will be used in all tests. The test will begin promptly at 9:00 AM. The tests will not wait for late arrivals.**

**THE LRC, INC. WC test specifies:**

1. A land single retrieve of approximately 50 yards in light cover.
2. Back to back singles or a double in the water. One bird should be retrieved in swimming water if possible.
3. The dog is not required to be steady or deliver to hand. However the judge may designate an area for delivery.
4. The dog should not be gun shy. \*

**WCX:**

1. A double marked land retrieve and a double marked water retrieve.
2. Dogs must deliver to hand. If the dog puts the game down for any reason, it may be commanded (but not assisted) to fetch up the game again. If the dog does pick up the game and complete the retrieve, no fault shall be seen.
3. AKC Senior Hunter Regulations and Guidelines will be followed with the following exceptions: Retrieves should not normally exceed 75 yards, and dogs CANNOT be handled on the marks.
4. This is strictly a marking test.\*

**ENTRY FEE IS:**

**WC (limit 50)**

**\$25 PER DOG FOR HRLRC members, \$35 PER DOG NON MEMBERS.**

**If your dog should fail the WC land you will be allowed to run water after the dogs in contention are finished.**

**WCX (limit 20)**

**\$35 PER DOG FOR HRLRC members, \$45 PER DOG NON MEMBERS**

**If your dog should fail the WCX land retrieve, you will be given the option of paying an additional \$10 to run the WC.**
