LAST MONTH'S MEETING MINUTES

Meeting called to order at 7:23pm by President, Pauline Mortier.

Secretary's Report- Minutes from March meeting read by Jeanine Asch and approved as read.

Treasurer's Report read by Al Reich. Approved as read.

Corresponding Secretary-Laura Reich had nothing to report

Newsletter- Stacy Quake has agreed to take over club newsletter editorship. Newsletter will be sent via email so please be sure email address is current with club directory and newsletter editor.

Specialty Show- John Steyn can not get AKC approval to judge at our Fall 2005 Specialty. A new judge needed to be procured. Diane Pilbin, Chucklebrook, has agreed to accept the regular bitch class assignment of John Steyn. Kendall Herr, Dickendall, will judge regular dogs & Intersex. Leslie Williams, Tantara, will judge sweepstakes.

Specialty Show Committee- Gary Cooper reported Monroe KC meeting is May 24th. MKC recommends hotels of Hampton Inn and Holiday Inn Express. If we share a judge with MKC they have agreed to pick up part of the judge's expenses. MKC had asked if we could use a judge for Golden Retrievers and Labradors on a Fee per Dog basis. Tentatively, Nancy Arbuckle has been secured for Sunday.

Additional Information: Breed Seminar this year will be the Sporting Group. Entry fees are \$24 per class with \$17 for each additional class and a 3 day parking pass will again be available. A \$30 veterinary fee will be assessed by each club. A \$2/dog grounds fee may also be assessed.

Labrador rings will be on the north side where the vendors used to be (by M-50). Rings must be 50' from any paved road per AKC rules. We would like to have a diagram of exactly where the rings will be located.

If we need tables, they can be rented for \$7/table. They will be nice fiberglass ones this year. It was discussed to have one for each of the three rings, plus tables for trophies, catalogs, raffle and hospitality. Chairs can be rented for \$0.50. We should rent at least 2 chairs per ring and for catalog sales for a total of 7 chairs.

Mike Merians motioned that we should give a pewter plate and slip leash to each regular class winner. 2nd-4th are to receive slip leashes. Jeanine was nominated to provide leashes for all class winners in the same manner as last year with redemption cards. Motion passed.

New Business:

Dave and Denise Misaris's application for membership was read by Jeanine Asch to the club. Letters of nomination from Gary Cooper and Mike Merians accompanied. Membership voted to accept Dave and Denise Misaris's application for HRLRC membership.

Letter from Northern Ohio LRC president, G Gaugler about donation solicitation for service dog Barron owned by Paula. Jeanine checked and \$1800 was still owed for ACL and TPLO surgery on legs. Motion made by Al Reich for \$100 donation from HRLRC be sent to the account. Gary Cooper has checked into the tent for the club's purchase. Costco has a similar tent for \$159 which has a round roof and a general size of about 10 x 20. Motion made by Cindy Skiba that different roof would be fine. He is still searching for the 10 plastic green chairs to purchase.

Nancy Chargo volunteered to take Sunshine Committee for 2005.

Motion made and passed for Gift Certificates be purchased by the club for the Barretts and the Johnsons.

Cindy Skiba's report on Raffle Donations for 2005 Specialty:

Motion made for gift certificates to be purchased from Val Cartright (Paws N Tails) for the large gifts as well as some of the club's purchases for raffle items. Contact persons for various donating organizations need to be got to Cindy (Vet Gen, Optigen, Schultz Vet, Animal Ophthalmology, Cindy Wheeler, OFA, etc).

A 50/50 raffle is also planned.

Raffle table will be worked in shifts and a sign up sheet will be developed.

Cathy Culpert has worked on contacting Dr. David Ramsey (Animal Ophthalmology) and Dr. Brown (Heart Auscultations) about a health clinic day. It was discussed for the possibility of the Friday before the fun day. She will check for availability on weekends vs during the week. It was discussed not to provide microchipping due to the loss of chips last time as well as the liability incurred by the club and person administering the chips.

Current status of the Club's trailer: Will be able to get to it if weather continues to dry out. It will be available for the picnic/fun day. A permanent plate will have to be purchased for it this year. The trailer should be covered by the auto insurance of whoever is towing it and the homeowners of whoever is storing it.
