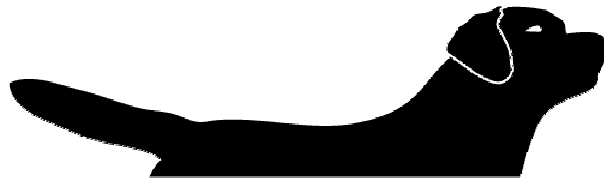
TREASURER'S REPORT- Approved as read.
